## FINDING A POSITION

Positions with the government in policy and international affairs vary significantly in terms of the type of work, extent of legal knowledge required and career options.

Each government organisation has its own separate recruitment program. Most will offer a standardised graduate recruitment scheme in the first half of the year. Some may offer seasonal internships. Keep an eye on the recruitment pages of the organisations you are interested in to find out more.



## **SKILLS & EXPERIENCE**

Students working in government, policy and international relations can expect to work on complex and varied projects. A good grasp of current affairs and strong communication skills will serve you well.

The nature of the skills necessary will vary greatly depending on which government department you are interested in. Think about how you can demonstrate interest in the area, whether it be learning a language, exchange, work experience or learning about the specialist area (finance, science, regional politics).



## DEPARTMENT OF FOREIGN AFFAIRS AND TRADE

DFAT provides policy advice to the government to assist in coordinating Australia's global, regional and bilateral interests. With many different career options in the organisation, it is ideal for students interested in international affairs.

DFAT have a two-year graduate program with five placements. Applications generally open in February.

# AUSTRALIAN COMPETITION AND CONSUMER COMMISSION

The ACCC promotes competition and fair trade in markets to benefit consumers, businesses and the community, as well as regulating national infrastructure services.

The ACCC has a one year graduate program. Keep an eye on their website for 2020 opening dates.
